#### 1. PURPOSE

This policy provides the basis for the allocation of credit point values to subjects and the associated student workload hours assumed within a subject for all NIDA degree programs.

#### 3. PRINCIPLES

- NIDA degree courses are a coherent accumulation of a body of knowledge resulting in the acquisition of specialist knowledge and skills and generic attributes.
- Our Bachelor degrees are levelled at AFQ level 7. The course and subject learning outcomes enable students to acquire and apply a coherent body of knowledge and skills aligned to the level 7 criteria and Bachelor degree descriptor.
- NIDA Bachelor degrees have 360 credit points. Bachelor degrees are typically offered full-time over three years and carry 120 credit points per year.
- Our Masters degrees are levelled at AFQ Level 9. The course and subject learning outcomes enable students to acquire and apply a coherent body of knowledge and skills aligned to the level 9 criteria and Master Degree descriptor.
- NIDA Masters degrees have 180 credit points. Masters degrees can be offered full-time (typically over 18 months) or part-time (typically over 3 years). Full-time Masters degrees typically carry 120 credit points in year 1 and 60 credit points in year 2.

- There is a direct relationship between the minimum level of student effort and time required for successful completion of a subject and its credit point value. 1 credit point carries a notational 10 hours of student effort.
- The credit point framework supports NIDA's educational aims and the consistency of the courses while providing appropriate flexibility for subjects directly related to productions.

### 4. POLICY

- 4.1 Credit points shall be related to student workload.
- 4.2 One credit point will notionally equate to 10 hours of student effort in a combination of staff contact hours and self-directed learning. In the case of Subjects directly related to production and industry placements (Work Integrated Learning) a consideration of one credit point equalling 15 hours of student effort in a combination of staff contact hours and production/placement activities is deemed acceptable.
- 4.3 It is recognised that the split between staff contact hours and self-directed learning time shall differ from discipline to discipline.
- 4.4 Ratios of Staff contact hours to self-directed learning time may reduce over the duration of a degree as students develop more autonomy in exercising skills and knowledge in practice.
- 4.5 All Bachelors courses will be structured on the basis of 120 credit points comprising the full-time workload for each year of study, giving a total of 360 credit points for the three (3) year courses.
- 4.6 All Masters courses will be structured on the basis of 120 credit points comprising the full-time workload for each year of study, giving a total of 180 credit points for the one and a half (1.5) year courses in full time programs or 180 across 2.5-3 years in part time courses.
- 4.7 A change to the credit points for a subject is considered a major change and is subject to course approval processes in accordance with the NIDA's Course Development, Review and <u>Approval</u> and Disestablishment policy
- 4.8 The credit point value of a subject must be clearly stated in subject outlines, course regulations, fee schedules and other relevant marketing material.

## 5. **DEFINITIONS**

Term	Definition		
Course Any of the Bachelor or Masters programs offered by NIDA.			
Credit Point	A unit of measure to indicate the student workload in a subject. One credit point will notionally equate to 10 hours of student effort consisting of a combination of face to face and self-directed learning. Credit points encompass contact hours, time undertaking assessments and self-directed learning hours.		
EFTSL	Effective Full Time Study Load (EFTSL) represents the total workload of a full-time student in any single academic year in a course where 1 EFTSL is 120 credit points.		

Full-time	Refers to a student who is enrolled for 100% or more of an Equivalent Full- Time Student Load	
Part-time	Refers to a student who is enrolled for less than 100% of an Equivalent Fu Time Student Load	
Non-standard progression	This term relates to the study pattern for any student not enrolled in a full-time load.	
Student workload	The number of hours a student is expected to engage with learning in a standard study pattern. Contact hours, where students engage in mediated and designed learning activities, can be comprised of a range of modes of teaching, including, practical classes, workshops, productions, placements, lectures, and tutorials as well as blended or online activities. Self-directed learning allows students to consolidate and expand on what they have learned by taking charge of their own learning outside scheduled class-time. This includes time for students to complete assignments, group work, readings / viewings and research, and to access NIDA equipment and facilities in accordance with availability and in compliance with relevant School guidelines
